Open for Public/Parent Comment (Mr. Pandey)

NOTE: Moving forward there will be a section for Public/Parent Comments on the board meeting agenda. Parents will have to submit their request of what they will be talking about. They

will submit this a day before the board meeting. Their request can only be made related to the agenda items that are listed on the agenda for that board meeting. Each individual can have up to two minutes. Parents must submit their request a day before on what they will be talking about by 4:00pm. They cannot come and vent their concerns. It will only be related to the board agenda. The board will have the right to refuse them.

How does a person who has an issue voice their concerns to the board? This process is listed on our website for parent complaints or concerns they might have. There are multiple levels. If they are not satisfied with all the levels, then it will go to the board. It will then become part of the executive session agenda and it gets added. This is when they can come and talk about their concerns. We cannot just have a person come and vent they must follow the process. They must submit their comments a day before to the Campus principal of whom the comments are being made against by 4:00pm in an email form. The campus principal will let the parent know if it can or cannot be discussed and these are the reasons why. Mr. Pandey, will be talking to the principals on November 1, on the process of parental complaints going to the board. Wanting the board to know as well just in case someone does show up you will know how to respond.

On the website will it be clear for the individual who does have a concern or comment how they will be able to voice their concerns? Yes, that is why the time line of a day before is so important so that the principals can explain the process and tell them why this will not be a part of the board agenda.

Discussion Items

Bond Updates: (Mr. Pandey)

At this point all the Texas properties all are under the bond. Ms. Whites company was involved in the underwriting side. Ms. White was not involved because of the conflict. We have all six campuses under a bond. There are no more leases.

There are three constructions approved under the bond as well. Those three are the Royse City – an expansion, Beltline – demolition 2 and three story building, and North Dallas - a swimming pool. There is still a process. North Dallas – we went to the city and found out that they require a PD amendment, they are not even putting that piece into the PNZ meetings until April. Once the PD amendment is done then we will go through the regular permitting process. After that then we will start the construction. I don't see North Dallas starting until August based on all these deadlines.

Royse City Campus – Delayed us a little bit because they adopted a 2019 building code. They were using a 2009 building code. We will need to put a storm shelter in and modify the plans. It will delay our construction a little bit. It will allow us to go through the process submission all at one time. That process will start by March.

Mesquite – requires a CUP. Every charter school that gets approved in the city of Mesquite are required a conditional user permit. Since Beltline Mesquite is already there and we are asking for improvements there should be no reason why they should deny us. We are improving the traffic flow and the usage of the building. It requires a process which we are looking at March for our CUP. We do have a tight time line.

We need to have the building demolished by the end of May and start construction. If that does not happen it will make us tight for one more year. Construction needs to happen from May until the follow year August when school starts.

Curriculum Updates: (Mr. Pandey)

We have received three additional grants since we last spoke. One thing TEA is doing better than some of the other states. They are providing a lot of grants connected to the learning losses as well as safety and security. We have been applying for several of these grants. We received a Jet grant which will allow our North Dallas and Mesquite Campuses to start offering Paramedic for our high school students. We also received the safety and security and the Covid expansion grant. This will allow us to keep our cleaning processes. We have a lot of other grants on the pipe line we are working for. TEA is one of the better ones then other states.

Community Event and Dallas Update (Ms. Haddox)

Two weekends ago we had heritage fun run and big family event which followed our JV football game. Last weekend we had a PTO carnival. We had a huge turnout. We had the Dallas police come over a join in with us and had a great time. I got in the dunk tank. The kids got in the dunk tank and really had a great time.

This week we have a PTAA international students with us from Korea. They are having a blast. We have seven students with us as they are shadowing with our 6th grade team. They have been doing things after school, as they are experiencing new things. Today at lunch they did a whole presentation for us. They did Taekwondo and a dance on the stage. Mr. Daniel told our kids how exciting it was going to be for them to come to Korea. The next 30 minutes there was a question and answering session and the students we so engaged. The fifth and sixth graders are so excited of the idea they might be able to go to Korea.

We just finished registering all of our High School Students and were accepted into Richland. We will be getting our PTECH up and running in January. The students we have the opportunity to take one or two classes and they are ready. Parkland just got a new director Vice President of IT. We are in partnership with parkland and going to build that program.

This morning I meet with some of our parents wanting to partner with us from TI. Wanting to see what TI can do for us with grants through the Robotics and Legos and things of that nature. One of the gentleman I meet with works for Facebook and one of their perks is they get the credits and promote other things. He wants to partner with us and use all of his credits to promote PTAA. He wants to use every credit he has earned to push PTAA to be amazing.

We have another gentleman that would love to start a media program. He has people that work in the TV and radio industry and they are also looking for one-minute fill spots. They are going to do a whole media presentation for us to maybe get that up and running. These parents are ready to grow.

North Texas student Day Ms. Roden and I took 10 High School students to the different news stations that were active for North Texas Student Day. We went as guests of the Ms. Johannesburg who is our college coach this year. She does best practices with robotics but she wanted to help promote our students in media. We did channel 8 and 11. It was

professional development exchange date so the kids were up here a 4:00 am in the morning. They were ready to go and represent PTAA. They had a blast. It was a fun morning. We put it on our Facebook.

November 3, best Robotics competition. We are having other schools come in and they will have their competition. We want to can see what it is all about before we jump in and spend money on this. Kids want to see what it is all about. We are going to be the host school.

It is a character in an elementary reading book. She is a hot mess. There is a book for any character. Yesterday was twin day. I told them if they didn't have a twin they could be my twin and we were dressing up in red shirts and jeans. About 70% were my twin yesterday. It was a fun day.

New Business: (Brent Parrott)

When Mr. Parrott taught he put together career week for the whole school. Kindergarten through eighth grade. The teacher would talk to the students on why do you need to learn this and relates to them in the future for their careers. We would have guests come in as well as parents to talk about their careers to the students. The students would choose a career they might be interested in and provide detail of this career in a presentation to the class. Get a grade on it. It was a very successful.
